Stats. 19.85 (g), to confer with legal counsel for advice concerning strategy to be adopted by the body with respect to litigation in which it is or is likely to become involved.

BIRT reviewed incident. Eggert moved to find there was a low-risk breach of confidential juvenile information. Powers seconded the motion and it passed it unanimously.

 #2020-008, 2-25-2020, DOA Region 2 - Bureau of Human Resources, Redgranite Correctional Institution, Division of Adult Institutions

BIRT reviewed the incident. Eggert moved to find there was a breach of DOC confidential information and that the institution in conjunction with the Region 2 Bureau of Human Resources should ensure the individual has been fully notified of the incident. The motion was seconded by Harris; BIRT passed it unanimously.

• #2020-009, 2-27-2020, Dodge Correctional Institution, Division of Adult Institutions

Powers departed the meeting.

Remaining members reviewed the incident. Eggert moved to find there was a low-risk breach subject to Wis. Stats. 134.98, and that Dodge Correctional Institution should notify the individuals involved. Donna Harris seconded the motion; BIRT passed the motion unanimously.
