Mail to RCI Inmates (No Money)

Money to RCI/STF Inmates (No Mail)

When sending a RCI/STF inmate money, all funds must be received in the form of a cashier's check or money order. The check/money order must clearly state the inmate's full name and DOC number along with the clearly printed name of the remitter. Any other types of funds received will be returned to the sender at the inmate's expense. Do not include notes or letters.
