SUBJECT: Daily Rates and Billing Policy for State Juvenile Correctional Services

The purpose of this memo is to inform you of the new statutory daily charges for State juvenile correctional services during the current biennium.

New Statutory Daily Rates

Under s. 301.26 (4), Wis. Stats., the Division of Juvenile Corrections is required to bill counties for juvenile correctional services provided by the Department of Corrections to delinquent youth placed with the department by the courts. The 2007-09 biennial budget, 2007 WI Act 20, changed the daily rates the State charges counties and other payers for services in a juvenile correctional institution, other out-of-home placement services and community supervision programs.
