<sup>1</sup> Design capacity is defined as the original design capacity of the institution, based on industry standards, plus modifications and expansions. It excludes beds and multiple bunking that were instituted to accommodate crowding.

<sup>2</sup> Population counts include inmates physically present at 12:00 A.M. plus reported beds held. This reporting policy applies to all DOC adult inmate facilities and both in- and out-of-state contracted beds.

<sup>3</sup> Midnight Count includes all juvenile offenders under the responsibility (on & off grounds) of each institution at 12:01 A.M. Friday morning.

<sup>4</sup> Total Capacity is a count of every bed in the facility, including security beds. Beds in security are not used to house general population youth.

<sup>5</sup> Due to technical issues an alternate method for extracting data from WICS was employed to produce this report. Occupied Beds will not be reported. The previous method will be resumed when the technical issues have been resolved.
