<sup>1</sup> Design capacity is defined as the original design capacity of the institution, based on industry standards, plus modifications and expansions. It excludes beds and multiple bunking that were instituted to accommodate crowding.

<sup>2</sup> Population counts include PIOC's physically present at 12:00 A.M. plus reported beds held. This reporting policy applies to all DOC adult PIOC facilities and both in- and out-of-state contracted beds.

<sup>3</sup> Midnight Count includes all juvenile Persons in Our Care (on & off grounds) for each institution at 12:01 A.M. Friday morning.

<sup>4</sup> Total Capacity is a count of every bed in the facility, including security beds. Beds in security are not used to house general population youth.

<sup>5</sup> Population includes youth who are AWOL, youth who are being supervised in other states, and DJC youth that are currently in an Adult Facility.
