<u>PREA Compliance Manager</u> (PCM) - A designated facility-based employee who has the authority to coordinate the facility's efforts to comply with PREA standards.

PROCEDURE

I. General Guidelines

- A. On a yearly basis, or more frequently if needed, facilities shall review and update a response plan to coordinate actions taken following an incident or report of sexual abuse.
 - 1. Facilities shall use the template provided by the PREA Office as the basis for the plan.
 - 2. The PCM shall be responsible for creating and maintaining an updated plan.
- B. The PCM, in collaboration with the Warden/designee, shall determine whether there are any facility specific responses staff should take in addition to what is described in the template.
- C. At a minimum, the plan shall detail a response for the following staff members:

- 1. Staff first responders.
- 2. Medical and mental health staff.
- 3. Investigators.
- 4. Facility leadership.
- D. Facilities shall maintain a copy of the completed plan (e.g. printed or electronic) in a location accessible to all staff.
- E. Facilities shall ensure those with a responsibility within the plan are apprised of their duties and expectations.
