PROCEDURE

I. General Guidelines

- A. ICS training shall be coordinated and scheduled through the NIMS Steering Committee and PERS.
- B. The PERS shall maintain a list of instructors to utilize for scheduled courses.
- C. All ICS instructors shall maintain certification in accordance with FEMA/WEM standards.
- D. Facility Wardens/designee shall be responsible for monitoring training and compliance.
- E. Staff shall participate to the level of their training in the ICS structure.

II. ICS Courses

- A. IS/ICS 100 – Introduction to ICS
This course shall be taken via the FEMA website either individually online or in a classroom setting.
- B. IS/ICS 200 – ICS for Single Resources and Initial Action Incidents
This course shall be taken via the FEMA website either individually online or in a classroom setting.
- C. ICS 300 – Intermediate ICS
This course shall be taken in a classroom setting.
- D. ICS 400 – Advanced ICS
This course shall be taken in a classroom setting.

E. IS/ICS 700 Series

1. IS/ICS 700 – NIMS – An Introduction
 - a. This course shall be taken via the FEMA website either individually online or in a classroom setting.
2. IS 702 – NIMS- Public Information Systems
IS 703 – NIMS- Resource Management
 - a. These courses shall be taken online via the FEMA website.

F. IS 800 – National Response Framework – An Introduction

1. This course shall be taken online via FEMA website.

B. Staff shall submit and achieve approval via the DOC-1042 prior to attending any non-DOC sponsored, in-person NIMS/ICS training.
