The CCEP On-the-Job Training (OJT) Program offers a unique opportunity for employers to build a skilled workforce while reducing hiring and training costs. By partnering with CCEP, businesses gain access to motivated individuals who are eager to contribute and grow within their roles.

Through an OJT contract, employers commit to hiring participants in permanent roles at competitive wages. In return, CCEP reimburses 50% of the participant's wages for the first 120 days, based on the hourly wage. This win-win approach not only helps individuals rebuild their careers but also supports businesses in fostering skilled, dedicated employees.

INCENTIVES FOR PARTNERING EMPLOYERS:

The **Federal Fidelity Bonding program** offers a valuable safety net for employers, providing no-cost insurance against employee dishonesty. Through CCEP, businesses can request a **\$5,000 fidelity bond**—valid for six months—giving them peace of mind when hiring new talent. Best of all, there's zero paperwork for employers or new hires to deal with, making the process seamless and stress-free.

The **Work Opportunity Tax Credit (WOTC) program** is a fantastic incentive for employers looking to expand their workforce while benefiting from **up to \$2,400 in federal income tax credits**. By hiring individuals from designated WOTC target groups, businesses can reduce their tax liability while providing opportunities for those who need them most.

The process is hassle-free—a **CCEP Coordinator can pre-certify new hires**, allowing employers to easily request the tax credit with **minimal paperwork**. It's a win-win: employers save money, and qualified individuals gain meaningful employment.
