**SUBJECT:** Update Regarding Change of Placement to Type 1 Juvenile Correctional Facility

This memo is to inform you of the approved daily rates for juvenile correctional facility (JCF)<sup>1</sup> services provided by the state during state fiscal year (SFY) 2026 and SFY 2027.

Juvenile correctional facility rates are established as part of the biennial budget. The 2025-27 biennial budget was enacted July 3<sup>rd</sup>, 2025. The previous memo, #25-02, details the related billing policies and community supervision rates.

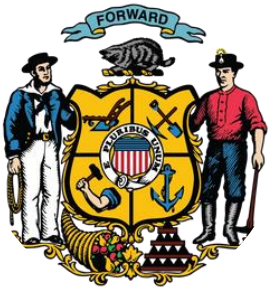
### Daily Rates

#### Juvenile Correctional Facility Rates

Under s. 301.26 (4), Wis. Stats., the Division of Juvenile Corrections is required to bill counties for juvenile correctional services provided to youth placed with the Department by the courts. The daily rate for services provided to youth in a JCF are shown below:
