**SUBJECT:** Update Regarding Interstate Compact for Juveniles Incoming Case Assignments

Effective January 2026, assignment of Interstate Compact for Juveniles (ICJ) cases from other states is overseen according to where the youth will reside and the youth's age, as follows:

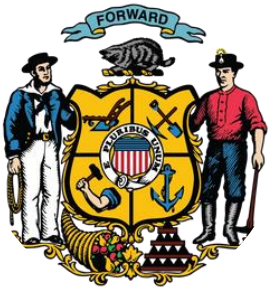
- Youth scheduled to discharge from supervision prior to age 18 will be assigned to the County for supervision.
- Youth scheduled to discharge after age 18 will be assigned to a Division of Juvenile Corrections Agent.

In cases where there are additional circumstances that may warrant a deviation to assignments, the ICJ office will communicate with the appropriate county Youth Justice Supervisor.
