New Appointments to Council on Offender Reentry

The first quarterly meeting of the Council in Fiscal Year 2024 welcomed two new members to the Council. Members of the council reported out on agency projects and initiatives that support a reduction in recidivism and improved outcomes for justice involved persons, as well as discussing opportunities for increased collaboration for the Council to consider.

December 13, 2023

The Council invited Zach Baumgart, Research and Policy Director at the Department of Corrections, to present to the Council on DOC's process for collection, storage, and dissemination of data. The DOC tracks numerous data points and encourages the Council and the public to review DOC's Interactive Dashboards¹ and Reports² found on DOC's website. Research and Policy collaborates with numerous external organizations and the Research Review Committee at the DOC reviews all research proposals, which include employees and persons in our care as research subjects. Chair Ray Woodruff discussed with the Council a data-sharing agreement between the Department of Corrections and Department of Workforce Development to assist in the case management of clients and the tracking of employment related outcomes alongside recidivism outcomes. Ray discussed with the Council considerations of additional data sharing opportunities to assist correctional clients and how data sharing could be mutually beneficial for all stakeholders to review and evaluate outcomes to better serve clients.

March 20, 2024

Chair Ray Woodruff discussed with the Council that the DOC can provide support for Grants Solicitations, letters of support, and/or data points to assist partners with grant solicitations. The DOC recently hired a Grants Coordinator position to assist the DOC (and partners) navigate the grant solicitation process.

The DOC introduced to the Council a client-provider information sharing application called Wisconsin Reentry Access Portal (WRAP) that the DOC has been developing. This application would allow for information sharing between clients on DOC supervision, community-based providers, and the DOC and can act as a reentry planning tool and resource for clients to assist reintegration upon release from incarceration. This application is still in the development stages.

The Council invited Bonnie Macritchie-Titze, Opioid Initiatives Director, Department of Corrections to present to the Council on the Opioid Use Disorder (OUD) Recovery Program at Milwaukee Secure Detention Facility (MSDF). The program seeks to increase and continue access to medication for those incarcerated with OUD at MSDF, reduce overdoses, and increase MSDF DOC staff knowledge and mitigation strategies. The DOC has expanded the OUD Recovery program to the Women's System starting July 1st and plans for systemwide expansion and working with county jails to ensure continuing medication.
