COUNCIL MEETING HIGHLIGHTS

October 16, 2024

New Appointments to Council on Offender Reentry

Wisconsin was previously accepted into the Medicaid and Corrections Policy Academy and the Council of State Governments (CSG) was asked to provide an overview of the Policy Academy and current Medicaid Policy with recent federal legislation. Lacy Adams and Samon Rouhani from CSG presented to the Council and discussed historically that Medicaid has had an "Inmate Exclusion Policy" which prohibited the use of Medicaid funds for people who are incarcerated. This can in turn lead to Medicaid coverage issues upon release from incarceration. Some recent Federal and State Policy efforts and impacts were discussed such as the Medicaid Section 1115 Reentry Demonstration Waiver, which allows Medicaid coverage for specific reentry benefits.

CSG then discussed the Medicaid and Corrections Policy Academy, which is a "cross-agency team composed of leaders from state corrections, Medicaid, and behavioral health agencies to develop a shared vision for implementing best practices related to Medicaid." Wisconsin is not a Medicaid expansion state and Act 370 prohibits Wisconsin from putting forth a Medicaid Section 1115 Reentry Demonstration Waiver, but Wisconsin is examining existing practice and policies to see where the state can enhance current operations for the correctional population.

January 15, 2025

Chair Ray Woodruff invited Jessica Gross, Bureau of Health Services (BHS) Director, Department of Corrections to present to the Council to discuss current operations of Healthcare in the DOC.

Jessica provided an overview on the structure of BHS to provide oversight and standardization of healthcare over the 36 institutions in the DOC to "deliver cost-effective, safe and high-quality patient centered health care, health promotion and preventive care in accordance with professional and community care standards." All 36 institutions are considered Primary Care Clinics and BHS has been working to streamline operations to increase the capacity of the DOC to assist Persons in our Care (PIOC). The DOC also has two Infirmaries, two inpatient units, and an Assisted Needs Unit to assist with surgery rehab and activities of daily living. The DOC is planning on creating a "Green Unit" which would be akin to a Nursing Home type Unit to reflect the needs of DOC's aging PIOC population. BHS is working to optimize the DOC's Electronic Medical Records (EMR) to allow for ease of use and increase providers ability to see more patients per day. Additionally, BHS is working to increase continuation of Medication for Opioid Use Disorders (MOUD) throughout the DOC system.

New Appointments to Council on Offender Reentry

Ray shared with the Council that April was 2nd Chance Month and highlighted two events to share with the Council. 2nd Chance Month is a nationally recognized effort to highlight opportunities and initiatives for individuals with justice involvement to successfully return to their communities after incarceration.

- 1. The DOC hosted its first Friends and Family Forum at Fox Lake Correctional Institution on April 9th, which provided an opportunity for attendees to ask questions, offer feedback, and positively contribute to our state's corrections policies. More information can be found on the DOC's Public Website. A newspaper article also discussed the event.
- 2. The DOC held an event at Kettle Moraine Correctional Institution's (KMCI) Job Lab on April 29th to recognize the partnerships that provide pre-release employment services and employment opportunities for the justice involved population at KMCI's Job lab. The DOC now has opened 17 institution-based job labs since 2019.

Ray asked Council Member, Kari Beier to discuss the ongoing contracted assessment of the DOC by Falcon Correctional and Community Services that began in 2024. Falcon is analyzing a scope of DOC practices that is not limited to the following examples: behavioral health, health care, restrictive housing, employee wellness, recruitment, and programming for the justice involved. Falcon analyzed data across topics, held over 20 group workshops and 15 onsite visits to evaluate DOC practices. Falcon is expected to submit its findings to the DOC in the coming weeks and the DOC plans to make the findings of the report public and share with the Council. The Council then discussed the Biennial Budget submitted by the Governor and their potential impacts on the justice involved.
