The State of Wisconsin is continuing the rollback of COVID-19 mitigation measures in its facilities, as viral activity [continues to decrease](#) across Wisconsin. [The limit of 3 people per in person visit will be lifted on 04/01/22](#). Each facility will return to allowing as many people per visit as was permitted pre-pandemic. The health and safety of our staff, inmate and Wisconsin communities remains a top concern for DOC. Should we experience a concerning increase in our positivity rate, our agency will work with health experts to again take the necessary measures to prioritize that safety. If you currently have an in person or zoom visit scheduled, they are still in effect and [valid](#).

Kenosha Correctional Center offers in person and zoom visits.

All visits must be requested two weeks in advance to allow time needed to notify all parties involved of the scheduled visits. [All visits are scheduled](#). No visitors are allowed to show up at KCC without scheduling a visit in advance. Inmates are allowed a maximum of three (3) visits a week. No more than two (2) in person visits a week. Once the visit has been scheduled, the inmate and visitor will both receive notice of the approved scheduled visit.

North side visiting Rooms 1-30

Mondays – Zoom visits from 6P-10P

Tuesdays – In person visits from 6P-10P

Saturdays – In person visits from 11A-4P; Zoom visits from 6P-10P

Zoom visits: are scheduled on every hour and every half hour

In person visits: Tuesdays from 6P-8P, 8P-10P; and Saturdays from 11A-1P, 1P-3P and 3P-4P

South side visiting Rooms 31-60

Wednesdays – Zoom visits from 6P-10P

Thursdays – In person visits from 6P-10P

Sundays – In person visits from 11A-4P; Zoom visits from 6P-10P

Zoom visits: are scheduled on every hour and every half hour

In person visits: Thursdays from 6P-8P, 8P-10P; and Sundays from 11A-1P, 1P-3P and 3P-4P

Holiday visits: In person visits will be held on recognized state holidays from 11A-1P, 1P-3P and 3P-4P for both north and south sides. Recognized state holidays are:

- New Year's Day January 1st
- Martin Luther King Day Third Monday in January
- Memorial Day Last Monday in May
- Independence Day July 4th
- Labor Day First Monday in September
- Thanksgiving Day Fourth Thursday in November
- Christmas Eve December 24th
- Christmas Day December 25th
- New Year's Eve December 31st
