Kenosha Correctional Center offers in person and video visits. Visitors will need to know what room number the Person in our Care (PIOC) resides in currently to know when that PIOC has visits. KCC reopens their doors again to offer <u>in person</u> visits. No advance scheduling for in person visits is necessary.

North side visiting Rooms 1-30

Mondays – Video visits from 6P-10P (6P-7P, 8P-9P and 9P-10P; 1 hour visit allowed once a week)

Tuesdays - In person visits from 6P-10P

Saturdays - In person visits from 11A-4P; Video visits from 6P-10P (6P-7P, 8P-9P and 9P-10P; 1 hour visit allowed once a week)

<u>Video visits</u>: Must be scheduled two weeks in advance by sending an email request to: DOCWCCSKCCZOOMVISITS@WISCONSIN.GOV

Video visits are scheduled for 1 hour at the times listed above. All video visits are scheduled in the order they are received.

<u>In person visits</u>: Arrive at KCC on the day and time visits are held. ALL visitors (even infants) must be on the approved visitor list or they will not be admitted.

South side visiting Rooms 31-60

Wednesdays – Video visits from 6P-10P (6P-7P, 8P-9P and 9P-10P; 1 hour visit allowed once a week)

Thursdays - In person visits from 6P-10P

Sundays - In person visits from 11A-4P; Video visits from 6P-10P (6P-7P, 8P-9P and 9P-10P; 1 hour visit allowed once a week)
