

## COVID Re-Opening Visiting Guidelines for McNaughton Correctional Center

### Visiting at McNaughton has been modified due to COVID Restrictions/Guidelines

Visitors will schedule visits at least two business days in advance by using the current e-mail address for Zoom Visits. Please specify in person or zoom visit.

Institution Entrance Procedures will include a Covid Screening (Temperature and Symptoms check)

The following guidelines will be in place until further notice:

- Up to three approved visitors will be allowed for a specific visit with a PIOC. Relationship does not matter but at least one visitor must be an adult.
- Visitors will be required to test or show proof of negative test within 72 hours if the visit occurs before March 15, 2022. The requirement to test or show proof of negative test will be lifted March 15<sup>th</sup>.
- Brief hugs are allowed at the beginning and end of visit; kisses are not allowed.
- Hand holding and sitting on laps is not allowed.
- All visitors age 2 or above shall wear a mask for the duration of the visit (except when eating or drinking).
- All PIOC shall be required to wear a mask for the duration of the visit (except when eating or drinking).
- Food and/or drink are allowed, but cannot be shared amongst visitors and PIOC.
- Outdoor visiting will require the same processes/restrictions.

McNaughton Correctional Center is a tobacco free environment. Tobacco products will need to be secured in your vehicle.

Electronic Devices, Cell Phones and Cameras are not permitted and must be secured in your vehicle.  
Pets are not permitted (with the exception of service animals)

### Visiting Hours at McNaughton have been modified due to COVID Restrictions/Guidelines

Visits will be limited to three hours

- Fridays 6:00pm-9:00pm
- Sat, Sun & Holidays 8:30am to 11:30am and 12:30pm to 3:30pm Note: If a holiday comes on a Friday, follow Holiday hours, there will be no evening visits.

Visitors will not be admitted if they do not arrive 30 minutes prior to the end of visiting hours.

McNaughton Correctional Center recognizes the following Holidays for visiting purposes;

New Years Day January 1st

Martin Luther King Jr. Day 3rd Monday in January

Memorial Day Last Monday in May

Independence Day July 4th

Labor Day First Monday in September

Thanksgiving Day Last Thursday in November

Christmas Eve December 24th

Christmas Day December 25th

New Years Eve December 31<sup>st</sup>

All visitors 16 and over must present identification upon request prior to the approval of a visit.

Acceptable forms of identification are:

- State Drivers License
- State Picture ID
- Passport (current)
- Military ID
- Department of Transportation picture ID card
- County Welfare Dept. Picture ID card

#### **Basic Procedures/Guidelines**

Visitors must dress appropriately, visits may be denied for inappropriate clothing. A list of non allowed clothing is posted in control area.

Adult visitors are responsible for the supervision of minors accompanying them. Visits may be terminated due to unruly minors or lack of supervision of the minors. An Adult must accompany any visitor under age 18.

Visiting with other inmates or visitors is not allowed unless prior approval has been granted.

All Containers, Purses and diaper bags will be checked and inspected by security staff.

The use of loud, offensive or vulgar language may result in termination of your visit.

Any visitor exhibiting signs of Alcohol or other drug use, as determined by the sergeant, will not be allowed to visit.

No property items for inmates are to be brought in on visits unless prior approval has been granted.

#### **Outside Visiting**

Picnic benches and tables are provided in the outdoor visiting area.

- Do not straddle benches
- Do not sit or lie on the ground
- Do not sit on top of the tables
- Do not move the tables

This is not a complete list of visiting rules and policies for McNaughton Correctional Center it is a representative guideline for what is expected when visiting.
