### VISITING INFORMATION

- ✓ There are have been some modifications to how visits will be conducted as we are still experiencing the COVID-19 pandemic and the Administrative Rules are still suspended. The Dining Room will be set-up to ensure proper social distancing. This schedule may change at any time or cancelled for health and safety reasons.

#### Workhouse In-Person

##### General Population

- Tuesdays: 6:00 pm – 8:00 pm. (Visits limited to two hours.)
- Saturday, Sunday, Holidays: 1:00 pm – 4:00 pm. (Visits limited to two hours.)
- ✓ Maximum number of persons permitted on a visit, six adults and their minor children, not to exceed a total of twelve.
- ✓ Visiting hours may be shortened if the number of visitors exceeds the allotted space.
- ✓ Visitors will be required to pass a COVID-19 Screening procedure for temperature and symptoms prior to being allowed to enter the visiting area.
- ✓ Visitors will not be accepted after 7:30 pm on weeknights or after 3:30 pm on weekends and holidays.

#### Zoom Visitation

- Mondays, Wednesdays, Fridays: 8:00 am – 11:00 am; 1:00 pm - 4:30 pm; 5:30 pm – 7:30pm
- Tuesday: 1:00 pm – 4:30 pm
- Thursday: 8:00 am – 11:00 am and 1:00 pm – 4:30 pm: 5:30 pm – 7:30 pm
- Saturdays, Sundays, Holidays: 8:00 am – 11:00 am
- ✓ All zoom visits are limited to ½ hour. One visit per week. The week runs Monday – Sunday.
- ✓ SCHEDULING A VISIT: Visits must be scheduled at least two business days (excludes Saturdays, Sundays and holidays) in advance. You may only schedule one visit at a time. Please email: [docdaistfzoomvisits@wisconsin.gov](mailto:docdaistfzoomvisits@wisconsin.gov) and **specify a ZOOM visit in the subject line**. Visitors may only schedule one visit at a time
- ✓ Visitation may only occur during non-programming time.

#### Legal/Professional Visits

- Must be scheduled 24-hours in advance.
