The Division of Adult Institutions shall provide for the temporary release of inmates from correctional facilities for purposes outlined in Wisconsin Administrative Code s. DOC 325.01.

PROCEDURE

I. General Guidelines

- A. A completed, approved, signed DOC-45 shall be processed for each individual inmate temporary release.
- B. A DOC-45 is not required for work release, project/community service crews, inmate drivers or study release placements. A DOC-2570 is required per DAI Policy 325.00.08.

- C. Only the Warden/designee may order the temporary release of an inmate.
- D. In the event of a medical emergency or natural disaster, the Warden/designee may authorize the release, as necessary, without following this procedure. However, a DOC-45 shall be completed as soon as feasible after the release.

II. Facilities Shall:

- A. Complete the request section of the DOC-45 in WICS.
- B. Forward the DOC-45 to the Warden/designee.
- C. If approved, determine the conditions of release in accordance with Wisconsin Administrative Code s. DOC 325.07 including the level of supervision required.
- D. Attach a copy of the inmate’s photo or DOC-120.
- E. Ensure a copy of the DOC-45 is maintained. Designated staff shall enter the departure and return time into WICS.
- F. If necessary, cancel the release order at any time in accordance with Wisconsin Administrative Code s. DOC 325.12.
