In any county that opts to offer a reduced minimum period of imprisonment for the successful completion of a probation period that includes alcohol and other drug treatment,

346.65(2)(cr) -- A person may be sentenced under this paragraph or under par. (bm) or (cm) or sub. (2) (bm), (cm), or (dm) or (3r) **once** in his or her lifetime.

** 346.65(2) (bm) 2 convictions in 10 years (***without a child under 16 in the vehicle***) Sentence may be reduced to not less than 5 days nor more than 7 days

*** 346.65(2) (cm) 3 convictions in a lifetime (***without a child under 16 in the vehicle***) Sentence may be reduced to not less than 14 days

**** 346.65(2) (dm) 4 convictions in a lifetime (***without a child under 16 in the vehicle***) Sentence may be reduced to not less than 29 days

***** 346.65(2)(3r) 1st Causing Injury (***without a child under 16 in the vehicle***) Sentence may be reduced to 15 Days
