SUBJECT:	Daily Rates for State Community Supervision Services

This memo is to inform you of the new fiscal year 2019 daily rates for community supervision services provided by the state.

## **Daily Rates**

Daily rates for supervising youth in the community are calculated on an annual basis and approved by the Legislative Joint Committee on Finance. The Joint Committee on Finance approved two rates for community supervision services provided by the state during state fiscal year 2019 including a "home" and "alternate care" supervision rate. These rates will be in effect from 7/1/2018 through 6/30/2019.

A home rate will apply to each youth receiving community supervision services residing at home or in certain transitional living placements. An alternate care supervision daily rate will apply to each youth residing in a residential care center, group home, foster home, treatment foster home, or in certain transitional living placements. Please note that the alternate care supervision rate is assessed for the costs of supervision provided by the State; additional charges for placement may apply. Additional details on community supervision billing policies can be found in <u>Administrator's Memo #17-06</u>.

The per person daily cost for the community supervision services are shown in the following table:

Home Placement Supervision	\$ 186.00
