SUBJECT: Juvenile Correctional Facility Rates

Juvenile correctional facility rates are approved as part of the biennial budget. Following the passage of the 2019-21 biennial budget, 2019 Wisconsin Act 9, this memo is to inform you of the approved daily rates for juvenile correctional facility (JCF)¹ services provided by the state during state fiscal year (SFY) 2020 and SFY 2021. The previous memo, #19-03, details the related billing policies and community supervision rates.

Daily Rates

Juvenile Correctional Facility Rates

Under s. 301.26 (4), Wis. Stats., the Division of Juvenile Corrections is required to bill counties for juvenile correctional services provided to delinquent youth placed with the Department by the courts. The daily rate for services provided to youth in a JCF are shown below:
