SUBJECT: Lincoln Hills School (LHS)/Copper Lake School (CLS)-Transferring of Youth

during COVID-19 Pandemic

In response to the ongoing COVID-19 pandemic, the Division of Juvenile Corrections (DJC) has determined it essential to implement further changes affecting admissions of youth to LHS and CLS. Effective immediately, all youth who are planned to be transported to LHS and CLS shall have health clearance by a health care professional verifying that the youth is without:

- 1. Fever
- 2. Cough
- 3. Shortness of Breath
- 4. Chills and body aches
- 5. Known contact with a COVID-19 positive individual within last 14 days.

Along with having a current temperature documented prior to transportation.
