Friends and Colleagues,

I would like to take this time to wish you all a happy, safe, and healthy holiday season. This year has been unlike any other in recent memory, so it is more important than ever to celebrate the holiday season with loved ones, whether in person or in a virtual environment. I would also like to send my condolences to those who have lost someone this year or been personally affected by this public health crisis. I recognize this holiday season may be difficult for both you and those in our care, and I will be keeping you all in my thoughts. I hope you can draw strength from friends and family during this difficult time.

I'm sure the COVID-19 pandemic is at the very top of your list of concerns this holiday season. We hear and empathize with these concerns, which echo the concerns of everyone in our agency. The DOC continues to work closely with the Wisconsin Department of Health Services (DHS) and review the National Center for Disease Control and Prevention (CDC) guidelines for updates, and we are following their COVID-19 recommendations as best we can in the institution setting. I ask that you continue to show patience, respect and appreciation for the essential staff who risk their own health to keep our institutions safe every day.

We are working diligently to prevent the spread of COVID-19 in our institutions, and keep both your loved ones and our staff safe. Thankfully, the rate of new, positive cases in DOC institutions has dramatically slowed in recent weeks, as has the number of those our care actively battling the virus. I imagine that many of you have heard talk of COVID-19 vaccines and are wondering where Persons in Our Care fall on the list of those to receive vaccines. While we don't yet have a concrete timetable for when this will happen, the DOC's Emergency Operation Center has put together a vaccine task force to work with the Department of Health Services and our local health agencies to ensure we advocate for our staff and those in our care, and get vaccines to our institutions as soon as it is possible. As we learn more, we will update that information on our public website, so I encourage you all to check DOC's public COVID-19 webpage frequently for the most up-to-date information (doc.wi.gov/COVID19).
